Guarantor must fill out application and provide all information required. Payment must be made via Money Order ONLY.

Acceptance of said fees is not to be construed as acceptance of tenancy application. Applicant will sign an authorization allowing Kaled Management Corp. to obtain credit information. Kaled Management Corp. will obtain a credit and income verification, and based upon that will determine the amount of security applicable. All applicants are required to have a yearly income (base pay, does NOT include tips, bonus, etc.) of at least 50x the monthly rent and a minimum credit score of 750 (using the FICO scoring system*). There are no EXCEPTIONS!! Guarantors are required to have a minimum credit score of 750* and have sufficient income to cover their own bills in addition to the person for whom they are providing the guarantee. Guarantor must have their primary residence in NY. **If application is missing ANY items, it is grounds for an automatic denial.**

The Landlord will in no event be bound, nor will possession be given, unless and until a lease executed by the landlord has been delivered to tenant. The applicant and his/her references must be satisfactory to the Landlord. No representations or agreement by agents, brokers, or others are binding on the Landlord unless included in the executed lease.

It is understood that security is NON-TRANSFERABLE. Security on current apartment will be refunded provided there are no damages or extra work required in the unit, tenant remains until end of the lease and fulfills all lease obligations.

I hereby warrant that all my representations set forth herein are true. I recognize that the truth of the information contained herein is essential. I further represent that I am not renting a room or an apartment under any other name, nor have I ever been dispossessed from any apartment, nor am I now being dispossessed and that I am over 18 years of age.
